- 1900 px long side, flattened 8 bit jpg format, sRGB color space.

- **Registration Page**; mail or scan to .pdf; email: VOL, info@trilakesarts.org.
- Artwork may or may not be for sale. Commissions: 60 artist/40 gallery of listed price.
TLCA will send sales commission money to the artist no later than Jun 1st.

PRINT --> max outside dimensions including frame-**36x36**

- All artwork must remain for the duration of the show.
 - Do NOT embedded in image digital frames, titles, watermarks, artist names, or text.
Identification will be covered during the jury process.
 - Max weight: 30 lbs
- ON BACK of each print: **title, your name, phone #, price**
- Print/frame/mount/wire for hanging in a professional manner.
- *No clip mounts, sawtooth hangers, or missing wires. Wire mounting only.*
- If the above criteria are not met, the photograph may be excluded from the show.

JURY, JUDGING and AWARDS

- A. Up to 3 jurors will select images for show; B. Show Judge will determine awards
- **6 Award areas: BEST OF SHOW, ORIGINALITY, TECHNICAL EXCELLENCE, COMPOSITION, OVERALL IMPACT, ARTISTIC MERIT**

BIN ART: 1. Provide your own bin; 2. **Clearly label** each item with **name, price, title**; 3. Typed reference list attached to TLCA's BIN ART FORM; 4. **Check in** with TLCA gallery assistant.
